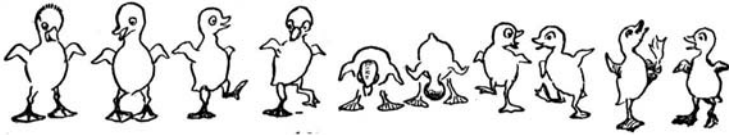

- In Tests and for Move-ups from a Test Class to a Trial Class, Alternate Entries shall be given priority over dogs that are eligible to be moved-up. Within the Trial Classes, requests to move-up shall be given priority over alternate entries.
- Bitches in season shall be eligible and will run at the end of the class in Tests and in catalog order as listed in the class in Trials.
- Please clean up after your dog and yourself. We ask the cooperation of exhibitors in helping to keep the Test-Trial location as clean as possible in order for us to retain the use of this facility for future events.

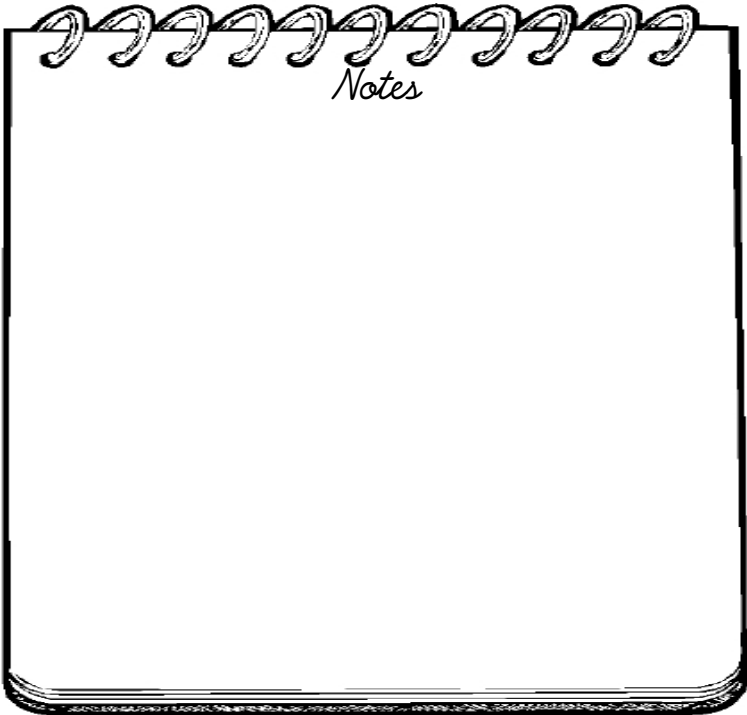

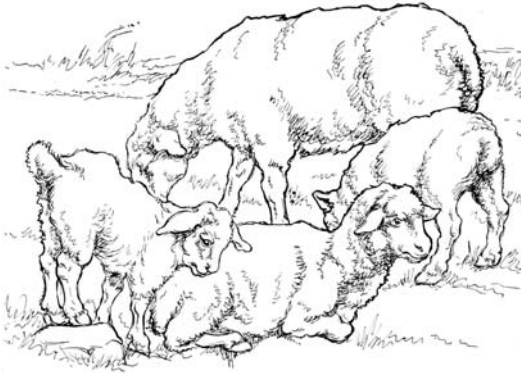
